## PROFESSIONAL SERVICES:

Minimum Services of the Funeral Director and Staff: Our services include, but are not limited to, personnel on duty 24 hours a day to respond to your initial request for service, care and sheltering of the remains, preparation and filing of the death certificate and permits as necessary, consultation with the family, and coordination of service plans with the cemetery, crematory and others responsible for the final disposition of the deceased. This fee also includes a proportionate share of our basic overhead costs such as facility maintenance, administration, insurance, equipment and inventory costs and governmental compliance. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

#### PREPARATION:

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. Our services (without viewing, rites or ceremony at the funeral home) include basic services of the funeral director and staff, a proportionate share of overhead costs, removal of remains from place of death (no mileage fees within service area of Bastrop, Bexar, Blanco, Caldwell, Comal, Guadalupe, Hays and Travis Counties), embalming, airline approved combination container, and transportation to the Austin or San Antonio airport.

#### DIRECT CREMATION: (\$640.00 to \$950.00)

Our charge for a direct cremation (without viewing, rites or ceremony at the funeral home) include basic services of the funeral director and staff, a proportionate share of overhead costs, removal of remains (no mileage fees within service area of Bastrop, Bexar, Blanco, Caldwell, Comal, Guadalupe, Hays and Travis Counties, three days of refrigeration prior to cremation, obtaining necessary authorizations and consents, and transportation to the crematory. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is unfinished fiberboard and can accommodate remains that weigh up to 300 pounds. We also include the crematory fee for remains up to 300 pounds. The cremated remains will be returned in a temporary container constructed of plastic.
